New Corporate Name and Logo

Our new name, Cboe Global Markets, Inc., builds on the brand capital of CBOE and the global reach of our collective businesses. You'll notice in Cboe Global Markets, the word "Cboe" is title-case vs. all uppercase, and is now pronounced "See-bo" instead of "C-B-O-E." This subtle change signals how our company has greatly expanded beyond its options heritage to a business with multiple asset classes and a much larger global footprint. In our new logo (the Global Markets version shown above), the arrow represents our forward momentum and is positioned high in our name to highlight our mission to power your potential.
